## WIND GUSTS | CLEARING | 60'S | COOLER

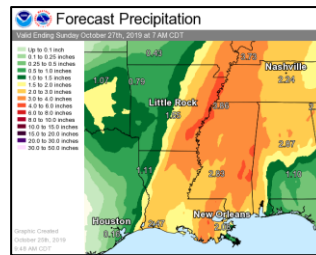

**SUMMARY:** Morning rain with afternoon clearing, possible 20mph wind gusts. Weekend weather sunny. New tropical storm formation affects gulf states. California wildfires and fire weather may cause another power shutdown.

**WEATHER:** Rain, mainly between 11 am and 2 pm. High near 60. South southwest wind 6 to 16 mph becoming east in the afternoon. Winds could gust as high as 20 mph. Saturday Mostly sunny, high near 55. Sunday sunny, high near 56. North wind 10 to 14 mph, with a low around 34.

**TROPICAL STORM:** Newly-formed Tropical Depression 17 may briefly become a tropical storm before being absorbed by a cold front. Regardless, heavy rainfall in excess of 2 inches is likely along the Central Gulf Coast along with Gale-force winds and coastal flooding.

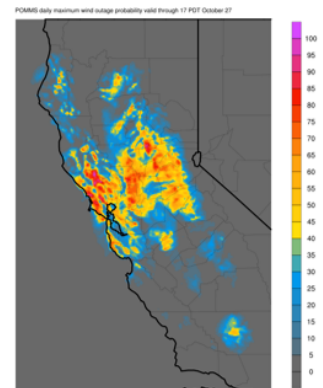


## POTENTIAL OCTOBER 26 – 28 PSPS EVENT

## ELEVATED WEATHER SYSTEM APPROACHING THIS WEEKEND

**PG&E is monitoring weather conditions which may require another power shutoff.**

- **Early forecasts (48+ hours out)** show the following:
  - Strong offshore winds and dry conditions beginning Saturday night
  - Peak wind gusts of 60-80 MPH in certain areas
  - Widespread Red Flag Warnings expected
  - Weather lasting through Monday afternoon
- **Additional analysis** is currently underway



Following the wildfires in 2017 some of the changes included in this presentation are contemplated as additional precautionary measures intended to further reduce future wildfire risk.

**CALIFORNIA WILDFIRES:** PG&E may once again turn off power due to widespread Red Flag Warnings. Many wildfires are burning taxing resources across the state.
